Terms of Use Revised 05.2023

1. Agreement

Food Banks Canada ("we") welcomes you to our network collaboration Sites, https://foodbankscanada.powerappsportals.com/ and https://foodbankscanada.workplace.com/ (the "Sites"). This Sites are forums of organizations engaged in food banking in the effort to address food insecurity in communities across Canada (individually the "Organization" and collectively the "Organizations").

By accessing and using this Sites, you (and your parent/legal guardian on your behalf, if you are under the age of majority in your jurisdiction of residence) signify that you have read, fully understand and agree to be legally bound by these Terms of Use (the "Terms of Use" or "Agreement") and to comply with all applicable laws and regulations as they may change from time to time. IF YOU DO NOT ACCEPT AND AGREE TO BE LEGALLY BOUND BY AND COMPLY WITH THESE TERMS OF USE, YOU ARE NOT PERMITTED TO ACCESS OR USE THE SITES.
